Legislative Update

### 2024 Authored Bills

#### LEGISLATIVE BILL PACKAGE

**AB 1246 – Public Employee's Retirement System, Optional Settlements –** AB 1246 allows a retired CalPERS member who divorces after retirement and subsequently remarries to designate their new spouse as a beneficiary for the member's share of retirement.

**AB 1808 – Childcare and development services: eligibility –** AB 1808 will align the eligibility period for child care support under the CalWORKs program with other subsidized programs, extending it from 12 to 24 months. This change aims to create consistent rules for families in need, regardless of whether they access support through welfare, community-based structures, or county offices.

**AB 1924 – Sacramento Regional Transit District –** AB 1924 authorizes the Sacramento Regional Transit District (SacRT) to include, within its defined service territory, any portion of Sacramento County if they choose to opt in and be included.

**AB 2301 – Sacramento Area Sewer District Pension Protection Act of 2024 –** AB 2301 ensures that employees of the newly merged Sacramento Area Sewer District (SacSewer) maintain their legacy status and retirement benefits under the Sacramento County Employee Retirement System (SCERS), and not be considered new employees.

**AB 2317 – Child day care facilities: anaphylactic policy –** Elijah's Law, AB 2317, requires that every childcare provider has a comprehensive anaphylaxis plan that complies with state and federal language access laws. Equipping our childcare providers with the tools to identify, prevent, and take quick action when a child suffers from anaphylaxis is critical to safeguarding the lives of California's infants and toddlers.

**AB 2576 – Diversion: attempted murder –** AB 2576 ensures public safety by recognizing that attempted murder is a violent offense whereby offenders should not be released back into the public with minimal accountability.

**AB 2992 – Real Estate Licenses –** AB 2992 will mandate that a buyer's agent in a real estate transaction have a written buyer/broker agreement with the buyer similar to how a seller's agent must have a written agreement with a seller.

**AB 3042 – DNA Crime Lab –** This bill would eliminate the sunset date in Government Code section 76104.6(b)(1) to ensure a permanent, steady source of non-General Fund revenue to support DNA programs aimed at solving violent crimes and exonerating the innocent.

**AB 3196 – Summary Proceedings for Obtaining Possession of Real Property: Demurrers –** AB 3196 aims to enhance the efficiency of legal processes in commercial property disputes by setting a definitive schedule for demurrer hearings. AB 3196 will reduce delays and financial hardships faced by small property owners and new small businesses. This bill is crafted to address the specific challenges within commercial real estate only, ensuring swift resolutions and enabling a healthier economic environment for small enterprises, without impacting residential legal proceedings.

**ACR 150 - Developmental Disabilities Awareness Month -** March is recognized nationwide as Developmental Disabilities Awareness Month, which honors the progress in, and opportunities for, supporting community life for people with developmental disabilities.
